What are the key features of this product?

- This is a fixed rate mortgage product, which means your monthly payments won't change during the term of the product. The initial rate of 5.51% is fixed until 31 July 2028, after which our Standard Variable Rate (SVR), currently 7.34%, will apply for the rest of your mortgage term. Interest is calculated daily.
- At the end of the fixed rate period, our SVR, currently 7.34%, will apply for the rest of your mortgage term.
- Before this product ends, we'll contact you with the options available. If you do nothing at the end of the product period, the rate charged will change to our SVR. This could mean that your payments increase. Our SVR is set by us and may go up or down in the future. Our SVR is currently 7.34% and will not fall below 3.00% at any time during the life of the mortgage.
- This product is available on:
 - a Capital and Interest repayment basis. This means your monthly payments will cover the interest due for the month and a portion of the amount borrowed. Provided all payments due are made in full and on time, your mortgage will be fully repaid at the end of the mortgage term.
 - an Interest Only repayment basis. This means that your monthly repayments will only pay back the interest on your initial loan. The capital balance will not reduce. You must have a suitable method of repaying the initial loan at the end of the mortgage term.
- A £1,495 product fee is payable. This can be added to the loan on completion; however, this will result in interest being charged on it making the overall fee greater over the term of the mortgage.
- This product comes with one free standard mortgage valuation for all purchase and remortgage applications.

Who is this product designed for?

This product is designed for Limited Company landlords who:

- are looking to purchase or remortgage a Buy to Let property which has an EPC rating of D-E.
- want or need the certainty of a fixed monthly payment for the term of the product.
- need a maximum loan to value (LTV) of 75%, excluding any fees added to the loan. The LTV is calculated using your current mortgage balance and our current assessed valuation of your property.
- want to borrow a minimum loan of £100,000 and up to a maximum loan of £1,000,000.

The product must be owned through a Special Purpose Vehicle Limited Company registered in England and Wales. This product is not available if you are a Portfolio Landlord or for HMO properties. All applications are subject to the Society's general lending criteria, property value and satisfactory status enquiries.

This product may be withdrawn with little or no notice.

Representative Example

The overall cost for comparison is given as the Annual Percentage Rate of Charge (APRC) and includes all fees incurred relating to the mortgage and product. The APRC allows you to compare the cost of different products.

On a mortgage of £250,000.00 on an interest only basis payable over 25 years initially on a fixed rate for 2 years fixed at 5.51% and then on our Standard Variable Rate (SVR) of 7.34% (variable) for the remaining 23 years you would pay:

The total amount payable would be £698,694.90 made up of the loan amount of £250,000.00 plus interest (£447,054.90), product fee of £1,495, a funds transfer fee of £25 and legal fee of £120. The overall cost for comparison is 7.2% APRC representative.
